## CORPORATE MEMBERSHIP FORM

THE FOLLOWING NOTES ARE APPENDED FOR THE GUIDANCE OF PERSONS WISHING TO APPLY FOR CORPORATE MEMBERSHIP OF THE CLUB:

Rule 18 provides *inter alia* that:

“Corporate membership shall be available to non-natural persons (e.g. companies, corporations, partnerships or trusts) who, upon recommendation by the Membership Committee and acceptance by the Main Committee shall be entitled to join as corporate members of the Club. The Main Committee will determine the rate of corporate membership annually to coincide with our subscription year as well as all the rules and benefits of the corporate membership.

A registration fee is payable on each application form and a Membership Card fee, as determined by the Committee (R200.00) for the main member.

Corporate Membership shall be for a period of 12 (twelve) months from the 1 March of each year or on a pro-rata basis and shall be renewable at the discretion of the Committee.

The Chief executive and the 4 floating membership cards shall be entitled to utilise all the facilities of the Club and enjoy all the privileges of membership, but shall not be entitled to vote at any meetings of members at the Club. Additional 6-10 members added to the corporate membership will only pay 85% of the ordinary member category subscription rate.

The corporation shall be held responsible for the payment of the monthly club account, Annual Subscriptions and any other charges and/or levies.

Applicants are requested to answer all questions with great care and in FULL and ensure that they have familiarized themselves with the Requirements and Benefits of Corporate Membership (see separate documentation) before signing this application form.

### Corporate Membership Fee Structure:

- R200.00 registration fee – Main member only
- R500.00 joining fee - Main member only
- R50.00 per card
