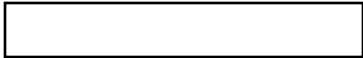

## SUMMARY OF GENERAL RULES AND BY-LAWS OF THE CLUB:

### MEMBERSHIP CARDS:

Membership cards are personal to the member whose name, number and photograph appears thereon and is **NOT** transferable. Members must always carry their membership card to gain admission to the Club and produce it when processing an F&B transaction at any of the Club's restaurants or bars. Temporary visiting members must obtain a temporary card from Reception.

### RECEPTION HOURS:

Monday to Friday: 08:00 – 19:00

Saturday: 09:00 – 16:30 (Reception Closed 13h00-13h30)

Sunday & Public Holiday: 09:00 – 14:00

### ACCOUNTS:

Monthly Club statements are sent to Members at the beginning of each month and are payable on presentation.

**OVERDUE ACCOUNTS WILL BE BLOCKED, CREDIT REVOKED AND HANDED OVER TO THE CLUB'S ATTORNEYS FOR COLLECTION.** It is the Members responsibility to ensure that should they not have received their monthly statement by the 5<sup>th</sup> of the month to notify the accounts department.

### COMMUNICATION FROM THE CLUB

All communication sent by the Club to all members will be done so electronically.

### CHILDREN AT THE CLUB:

Children under the age of 16 years are allowed to use the Club's pool and surrounding area, all sporting facilities (excluding the gym), the Barn & Waterside restaurants, provided that they are at all times accompanied by an Adult Member, who are solely responsible for ensuring children's safety and well-being, and consideration must be given to other Members using the facilities of the Club.

For clarity it is recorded that children may not visit the gym, Terrace and Coffee Shop.

The Club does not accept responsibility for any injury or other harm which a visiting child may suffer at the Club howsoever the same may be caused.

The following Rules apply to the pool and surrounding lawn area:

- No ball games permitted of any kind on the lawn area or in the pool at any time.
- No children are permitted on the wooden benches outside of the Pool bar sliding doors after 17:00.
- No children under the age of 18 years allowed access to the Pool bar under any circumstances (as per the Liquor Law).

### USE OF CELL PHONES:

The use of cell phones is not permitted inside any of the Club's buildings except for the Coffee Shop. Calls can be made or received outside of the buildings.

### NEWSLETTER:

A Newsletter containing all items of information and Club events, is sent to each electronically every quarter.

### RESIGNATIONS:

A member intending to resign, shall notify his/her resignation in writing to the membership department prior to **28 February annually**, upon which the forthcoming year's subscription becomes due. He/she shall otherwise be liable for the ensuing year whether or not he/she has used the facilities.

### CLUB CLOSED:

The Club is closed on Good Friday and on Christmas Day.

### DRESS CODE:

Neat, smart casual attire at all times. Members are expected to dress in a manner that reflects the dignity and traditions of the Club.

### PRIVATE MEETINGS:

Should a member wish to hold a meeting including a one-on-one meeting, a function room must be booked through the Banqueting Department.

## APPENDIX B – SUBSCRIPTION FEES

I hereby acknowledge that this membership **does not** terminate unless requested in writing to the membership department by no later than the 28<sup>th</sup> February each year.

- **Spousal membership** category can only be applied for by partners who reside in the same household and can provide proof (not older than 3 months) thereof. Should the partnership be annulled the spouse member will become a full member.
- **Country membership:** An Absentee / Country Member is a Member permanently residing outside the Magisterial Districts of the Cape, Wynberg, Mitchells Plain, Simon's Town, Goodwood, Bellville, Kuils River, Paarl, Somerset West, Strand and Stellenbosch, during the course of a complete subscription year and who has provided the Club with address and contact details to substantiate this membership category. Category classifications can only be changed annually before the commencement date of the new subscription year.
- **Junior Academy [JA]**
  - Children between the ages of 10-15 who have enrolled in one of the coaching sporting academies at Kelvin (Tennis or Squash).
  - R215 upfront registration fee.
  - This category of membership would entitle the child to full access to that specific sporting facility and its facilities.
  - If parent/s join at a later stage, no joining fee will be charged to them (valued at R500.00).

### **REQUIREMENTS FOR JOINING KELVIN GROVE CLUB:**

Thank you for your membership enquiry. I hope you will soon be joining us at Kelvin Grove Club as a recently accepted new member.

A registration fee of **R200.00 (excluding card fee R50.00)** and application fee **R300.00** is payable on each application form except for the **Junior Academy member** who will pay **R215.00** (including card fee) – one application form is required per candidate. One proposer and one seconder (these may be family members) will be required to complete the section on page 1. If you do not know anyone who fits this criteria, please attach a letter to the application form explaining this. Once the application has been completed in full, return it to the Club with the registration & application fee and **a copy of the candidate's ID or passport**. You will be given a receipt for this payment and the application takes approximately 6-8 weeks to process. Once approved, you will be notified in writing accordingly and attached to your acceptance letter, will be a pro-rata invoice for the balance of the year. If you would prefer to use the debit order option, please request the form to be sent to you. Our subscription year will run from **March to February** each year.

The annual fees are above and will entitle you to use all the facilities that the Club has to offer, at no extra cost. As a member of the Club, you will be entitled to bring guest(s) to the Club, **but only once a month**. If your spouse is not already a member of the Club, he/she will be treated as a guest.

The Club currently has reciprocal arrangements with approximately 41 similar clubs worldwide, of which you as a member, will be permitted to visit as stipulated in our reciprocal agreement. One of these clubs is the Kind David Mowbray Golf Club.
